I feel the excitement among staff and individuals for the new and renewed opportunities to live, work and socialize in our community. ARCA experienced enormous growth in 2023, welcoming 115 people into residential, vocational, rehabilitative, respite and day programs. ARCA's Community Integrated Employment Program alone worked with 53

adults to enjoy meaningful employment; ten have done such a great job they no longer need our help at work!
