In the early days of COVID, we all yearned for a return to "normalcy." Like Alice in Lewis Carroll's beloved children's book Alice in Wonderland, we realize the changes we've undergone have made us who we are today.

With restrictions lifted on who is allowed in our homes, we're catching up on chores like painting and household repairs. Beautiful homes make everyone happier! We're continuing work on our new ARCA Neuro Intake/Assessment facility funded through Bernalillo County Department of Behavioral Health. With the generous support of The Hartman + Majewski Design Group, construction documents and architectural drawings will soon be submitted to the State for approval. What an exciting opportunity for New Mexicans with an acquired brain injury and their families to transition from acute care to the next steps in their journey.

In the meanwhile, we continue to address significant staffing challenges agency-wide. Administrative staff from our program divisions are working shifts in our homes in addition to their other responsibilities. Temporary DD Waiver rate increases, an unexpected raise in ICF/IID rates and one-time CARES Act funding provided resources to raise our starting salary for Direct Support Professionals to \$13.00 an hour, Life Skills Teacher-Behavior Technicians to \$14.00 and Floaters to \$16.00. Full implementation of the 2019 Rate Study, annual cost of living increases and your ongoing support could sustain these rates. Passage of the federally proposed \$400 billion into Medicaid Home and Community Based Services (HCBS), known as the

Better Care Better Jobs proposal, could truly align wages with the essential work performed. After decades of advocacy, we will again reach out for your help in encouraging our 2022 Legislature to recognize the essential role of our workforce.

Thank you for supporting our journey in becoming who we are today and who we can be tomorrow.

ARCA Neuro

ARCA's Acquired Brain Injury program has a new name! ARCA Neuro provides residential and in-home

supports for acquired brain injury *(ABI)* survivors and their families. ARCA Neuro currently has two licensed homes, one home in the licensure process and an Intake/Assessment facility scheduled to open in 2023.



In September, ARCA Neuro reached a glorious milestone when the first brain injury survivor was successfully discharged from a New Mexico brain injury rehabilitation facility! Rickee's uncle said, "Two years ago, Rickee was carried out of our home. In September, he will walk back in." Rickee suffered a seizure resulting in his brain injury. When he arrived at ARCA, his family hoped for palliative care to help him find comfort. His body was too weak to sit upright in his wheelchair and he was unable to care for himself. Through consistent, structured rehabilitation, Rickee has regained his physical strength and no longer uses a wheelchair. His speech is clear and he is able to understand and control his behavioral outbursts. Rickee calls ARCA Neuro "a place of healing," but says "it doesn't stop here." Rickee's mom is grateful for the support she received during the process and said, "It was hard, but ARCA Neuro helped me understand what was happening. They brought my son back to me and I'll do anything I can to help them help others."

We are proud of Rickee and the difficult work he put in to his rehabilitation and discharge, but know he will always be in our lives. He is an inspiration and we are privileged to have joined him and his family on this journey.

National Direct Support Professionals Recognition Week

Direct Support Professional (DSP) Recognition Week is an opportunity to highlight the remarkable work of dedicated, innovative professionals who are the very core of supports for people with disabilities. At ARCA, we celebrate DSP week in September and throughout the year!

With the necessary supports, children and adults with intellectual, developmental and cognitive disabilities contribute to our community in real and meaningful ways. These supports come, each and every day, from people who choose to dedicate their lives as a DSP. It's a rewarding job, but one

What do ARCA DSPs think about their essential jobs? In ARCA's 2021 Engagement Survey, DSP comments included, "I love doing a job where I'm able to make a difference," "Every day there is something a bit different about the consistent task," and "I always feel my opinion is asked and heard."

ARCA is grateful to our dedicated DSPs throughout the year and celebrates with Back to School drives for school essentials delivered in a brand new backpack, Trunk or Treat offering a safe Halloween experience for kids of all ages and ARCA Day at the Zoo bringing friends and family together for a festive outing. Thanksgiving dinner is prepared and served every year and our Giving Tree is a chance for kiddos to get that special holiday gift a family might not otherwise be able to provide. ARCA is a family and these tributes are made possible through our staff and community coming together to recognize the challenges and cherish the time to celebrate one another.
